OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

"Antigua and Barbuda Dream Wedding" ("Contest") is open to legal residents of the 50 United States and the District of Columbia 21 and older. Employees of Antigua and Barbuda Department of Tourism. (the "Sponsor") and their subsidiaries, co-sponsors, affiliates, advertising and promotion agencies and their immediate family members and/or those living in the same household are not eligible to enter. Sweepstakes governed by U.S. law. Subject to all applicable federal, state and local laws and regulations. Void in Puerto Rico and where prohibited by law.

Engaged couples are invited to apply for the sweepstakes by filling out the official application form and submitting a one-page summary of how they met/got engaged along with a photograph of you and your fiancé together as a couple. Applications **MUST** be written clearly or typed and **MUST** be accompanied by the summary and picture.

Entries will be judged on a number of criteria to include creativity, passion, credibility, authenticity and romantic appeal.

Mail-in entries must be postmarked between April 1st and May 30th, 2010 and received by June 4th, 2010. Only one entry per couple will be accepted. All materials you send us will be retained by the Sponsors and become the property of the Sponsors and will not be returned to you whether or not you are selected as a participant. Any expenses you incur during the application process including postage, shipping and materials preparation (postage, photos etc) are your sole responsibility.

Unfortunately, we will not be able to verify that we have received your application. If you like, you may wish to send your application package via an expedited courier (such as Federal Express or UPS). They will provide a tracking number that you can use to verify the receipt of your package. The Sponsors are not responsible for lost, late, damaged, misdirected or postage due mail/entries.

Prizes/Approximate Retail Values ("ARV"): One (1) Grand Prize: Two (2) tickets for bride and groom ARV \$1,500. Connections will be made from a major commercial airport nearest winner's primary residence in the U.S. to attend Dream Wedding in Antigua and Barbuda. Offer includes four (4) nights' double-occupancy standard hotel accommodations including breakfast for two (2), dinner for two at restaurants selected by the Sponsors ARV \$5,000. Wedding package includes professional stylist (hair and makeup) for winning couple only ARV \$1,500, wedding bands ARV \$2,000. Package will also include services of a florist, photographer and videographer and a wedding reception for a party of 30. If Sponsors secure a wedding dress for the bride, she must agree to wear the dress on the wedding day scheduled for June 18th or June 19th, 2010. Odds of winning depend on number of eligible entries received, estimated at \$17,500 for the Grand Prize. Selection of professional stylist and wedding attire, hotel, reception, videographer, photographer or any other service required for the Dream Wedding Sweepstakes is to be determined solely by the Sponsors. If professional stylist is unavailable for any reason, Sponsors reserve the right to substitute a stylist of their own choosing or to cancel the consultation or wedding attire portion of the prize.

Grand Prize includes ground transportation from V.C. Bird International Airport, Antigua and to the host hotel and back, but does not include hotel incidentals, gratuities, service charges or any other expenses not specified herein, all of which are the responsibility of the winners. "Dream Sweepstakes" Winners must be sure to have valid passports and VISA if necessary as well as cover their own transportation to and from the airport in their residing cities.

Dream Wedding tickets cannot be transferred or sold. Winners and guests must comply with any security procedure or measures imposed by the wedding representatives, which reserves its right

in its sole discretion to suspend or cancel the participation of any winner or guest due to non-compliance with any security procedure or inappropriate behavior or misconduct. Actual value of trip depends on location of winner, airfare and room rates at time of stay. If actual value of trip is lower than ARV, the difference will not be awarded in cash. Winners and guests must travel together on dates specified by the Sponsors or forfeit all rights to prize. Blackout dates and restrictions may apply. If prize is forfeited for any reason, and there is sufficient time to notify an alternate winner, the prize will be awarded to an alternate winner in a separate random drawing from among all non-winning eligible entries. Winner and guest are responsible for obtaining proper documentation/passport prior to travel. Guest must complete and return a Liability/Publicity Release prior to travel except where prohibited by law. A parent or legal guardian must accompany a traveling minor. If the Dream Wedding is postponed, canceled, or if winner cannot travel for any reason whatsoever after all travel arrangements have been made the Sponsor shall have no further obligation to winner to supply a trip to the destination. Should Antigua and Barbuda be at fault for the cancellation of the Dream Wedding, the travel portion of the prize will be awarded to the couple only and must be taken within 12 months from prize notification date.

Winners will be selected from all eligible entries received by a panel of judges on or about June 5, 2010 under supervision of an independent judging organization ("judges") whose decisions are final. Winners will be notified by mail or email. Grand Prize winner will be required to complete and return an Affidavit of Eligibility and Liability and a Publicity/Travel Release ("Affidavit") as well as a Disclaimer, except where prohibited by law, within 7 days of date specified on notification, or an alternate winner will be selected. If an Affidavit or prize is returned as undeliverable, it will result in disqualification, and the corresponding prize will be awarded to an alternate winner in a separate random drawing. No substitutions are permitted except if a prize is unavailable, in which case a prize of equal or greater value will be awarded. Prizes are not redeemable for cash and are non-assignable or transferable except to a surviving spouse. Winners are responsible for all federal, state, local, sales and income taxes. Tickets will be awarded within 30 days after receipt of Affidavit or prize notification. Entry and acceptance of prize constitutes permission to use each winner's name, prize won, hometown and likeness for online posting and promotional purposes without further compensation, except where prohibited by law.

Participating entrants agree to these Official Rules and the decisions of the judges and the Sponsors, and release the Sponsors and their affiliated companies, and all other businesses involved in this Sweepstakes, as well as the employees, officers, directors and agents of each, from all claims and liability relating to their participation, acceptance and use of any prize.
